Re: GCSE Outdoor Activities Assessment – Hilston Outdoor Pursuit Centre

Having experienced a 'Taster Day' the GCSE PE students have the opportunity to be assessed at Hilston Park, Gwent Outdoor Centre. They will participate in an intense four-day course in one activity. The activities will be dependent upon numbers and pupils will have opportunity to withdraw if the activity they choose cannot be offered.

Outdoor activities can be offered as one of their four practical sports that count towards 50% of the GCSE.

The confirmed dates for this residential are as follows: Depart: **Monday 30th April** at 8.30 am **Return: Thursday 3rd May** at approximately 3 pm.

In order to make this trip viable, we have to ask for a contribution of **£240** to cover the cost of the educational visit, accommodation, food, transport and supply costs. Payment may be made in 2 parts if required, **£90.00 deposit** to be paid by **Friday 16th March** and the following payment of **£150.00** needs to be paid by **Monday 16th April**.

If you wish your son/daughter to participate in this event, you **must** sign both of the attached consent forms and return to **Mr Butler** ASAP as this is a legal requirement enforced by the LEA Insurance and Health and Safety departments. Failure to do so will preclude your child's attendance at this event.
